# SAHEL - FOOD INSECURITY AND COMPLEX EMERGENCY

### KEY DEVELOPMENTS

- In response to above-average international grain prices triggered in part by drought in the United States and Russia, the U.N. Food and Agriculture Organization (FAO) warned of increased prices during the height of the lean season in the Sahel, which corresponds with the onset of annual rains and Ramadan, the Muslim holiday observed in July and August this year. To counter increasing regional food prices, the governments of Mali and Niger reduced or eliminated taxes on basic imported food items to prevent further aggravation to food security in the region, according to international media.
- With the current rains, farmers have commenced planting activities. While the rains have improved general water availability, they also threaten to increase locust populations in agricultural areas of Chad, Mali, and Niger. In addition, the rains increase the likelihood of floods and a potential spread of waterborne diseases such as cholera, which is endemic to West African countries.
- USAID's Office of U.S. Foreign Disaster Assistance (USAID/OFDA) is providing nearly \$5 million for additional health, nutrition, and water, sanitation, and hygiene (WASH) activities in regions of Cameroon, Chad, Mali, Mauritania, and Niger.
- To address the humanitarian needs of Malian refugees displaced by ongoing insecurity in northern Mali, the U.S. Department of State's Bureau of Population, Refugees, and Migration (State/PRM) is providing more than \$3.6 million to six non-governmental organizations (NGOs) assisting refugees in Mali's neighboring countries.

#### Context

- Earlier this year, the U.N. estimated that nearly 19 million people in the Sahel were at risk of food insecurity in 2012, of which 8 million people would likely face severe food insecurity and require emergency food assistance, according to national government and U.N. data.
- In FY 2012, the U.S. Government (USG) is responding to disaster declarations in Burkina Faso, Cameroon, Chad, The Gambia, Mali, Mauritania, Niger, and Senegal.

# Regional

Additional desert locusts will likely hatch throughout the Sahel in the coming weeks, according to FAO. The
presence of locusts threatens agricultural production and livelihoods, particularly in Chad, Mali, and Niger. FAO and
national government locust survey teams have confirmed the presence of locusts in Algeria, Chad, Mauritania, and
Niger, and ground teams have treated approximately 1,200 hectares of land in Niger.

# Burkina Faso

• In late July, with funding in part from USAID/FFP, the U.N. World Food Program (WFP) distributed approximately 1,840 metric tons (MT) of food to more than 69,400 Malian refugees residing in northern Burkina Faso. In total, WFP assistance is supporting more than 1.1 million people countrywide.

• With the recent surge in Malian refugees in Burkina Faso—currently estimated at 108,000 people, compared to 56,000 in May—and the scale of resulting humanitarian needs, WFP has reported a shortage of resources. WFP reportedly retains food commodities sufficient to feed 60,000 refugees through September, although the organization estimates that at least 77,000 refugees will require food aid during this period. In FY 2012, USAID/FFP is providing more than \$6.8 million in U.S. food commodities for distribution to vulnerable populations in Burkina Faso.

#### Cameroon

- Drought and inconsistent rainfall in 2011 led to decreased agricultural production in Cameroon, particularly in North and Far North regions, where the prevalence of acute malnutrition among children under five years of age exceeds the U.N. World Health Organization (WHO) critical threshold level of 10 percent. The recent arrival of seasonal rains has left northern Cameroon at risk of developing cholera and other waterborne disease outbreaks, which would likely exacerbate the nutrition status of children under five years of age.
- To combat acute malnutrition in Cameroon, USAID/OFDA is providing \$1 million to the U.N. Children's Fund (UNICEF) for nutrition and WASH activities in the north. The program aims to expand coverage of acute malnutrition treatment programs and provide health facilities with essential medicines, equipment, and supplies. To reduce the spread of cholera, which can worsen acute malnutrition, USAID/OFDA is also supporting UNICEF's efforts to increase the availability of safe drinking water and improve sanitation conditions and hygiene practices in affected areas.

#### Chad

- As of July 31, rains during the current agricultural season in Chad had exceeded average rainfall amounts, according to the USAID-funded Famine Early Warning Systems Network (FEWS NET). The increase in rainfall has improved the availability of water and pastureland in agro-pastoral areas that produce rain-fed cereals. Farmers have also cultivated an above-average quantity of land this planting season due to relief agency- and government-sponsored seed distributions, as well as the Government of Chad's tractor lending program offered to rural farmers.
- Since August 2, approximately 540 MT of sorghum funded by USAID/FFP have arrived in the capital city of N'Djamena for WFP distribution. An additional convoy of trucks transporting food commodities is scheduled to arrive in the coming days.
- In nine of 11 regions in Chad's Sahel band, the prevalence of global acute malnutrition (GAM) in children under five years of age has surpassed 15 percent and exceeded the WHO emergency threshold, according to a Standardized Monitoring and Assessment of Relief and Transitions (SMART) survey conducted by UNICEF from May to June. In response, USAID/OFDA provided an additional \$1 million through UNICEF to reduce acute malnutrition by training community health workers in early identification, referral, and management of acute malnutrition, providing therapeutic foods to children, and supporting more nutritional surveys to monitor progress in target areas.

# Mali

- On August 10, the International Committee of the Red Cross (ICRC) began food distributions in Kidal Region, northern Mali, with plans to reach approximately 36,000 people. In July, ICRC distributed food commodities to 120,000 people in Gao and Tombouctou regions.
- Using USAID/FFP funding, Catholic Relief Services (CRS) continued to conduct food distributions for internally displaced persons (IDPs) and host families in Mopti Region, recently providing more than 65 MT of food to at least 3,600 individuals. USAID/FFP partner the Agency for Technical Cooperation and Development (ACTED) also continued food distributions for the approximately 12,000 IDPs residing in Bamako.
- USAID/OFDA recently committed an additional \$1 million to UNICEF to support an integrated response program
  that provides trainings on updated community-based management of acute malnutrition protocols, introduces
  positive infant and child feeding practices, and treats common childhood diseases through increased access to safe
  drinking water and other strategies. USAID/OFDA is also supporting UNICEF to provide WASH interventions.
- USAID/OFDA is providing more than \$1.1 million to Helen Keller International (HKI) to improve the community
  management of acute malnutrition in southern Mali. Through HKI, USAID/OFDA will train health workers and
  community volunteers in the detection, referral, and treatment of acute malnutrition in children under five years of
  age in Koulikoro and Sikasso regions. By strengthening local capacity, the program seeks to ameliorate the nutritional
  status of up to 45,000 children.

#### Mauritania

- The Office of the U.N. High Commissioner for Refugees (UNHCR) has postponed the opening of the previously announced second refugee camp in Aghor, Mauritania, located 17 km from Mbera camp, until refugee registration is completed. With a decrease in the number of new refugee arrivals—averaging less than 350 people daily in July following a spike to nearly 2,000 people per day in June—and a possible revision to reported Mbera camp population figures, UNHCR plans to reassess the need for a second camp in the coming weeks.
- In Mbera camp, multiple relief agencies continue efforts to increase access to water and sanitation services. NGOs Solidarités and Oxfam are working to construct boreholes, establish water distribution networks, and install latrines. In addition, UNHCR and Oxfam have constructed nearly 1,000 showers to accommodate refugees in the camp.
- In July, WFP provided USAID/FFP-funded in-kind food assistance to approximately 90,000 refugees in Mbera camp. In addition, between April and June, World Vision distributed USAID/FFP-funded food vouchers to approximately 4,070 vulnerable households in Kankossa Department, Assaba Region.
- With an additional \$250,000 in support to UNICEF, USAID/OFDA is reducing the prevalence of acute malnutrition in Mauritania through health worker training in the management of childhood illnesses and the improvement of family care practices. USAID/OFDA funding also ensures the provision of nutrition supplements to children under two years of age during the lean season.

# Niger

• USAID/OFDA is providing \$600,000 to Première Urgence to enhance the management of acute malnutrition in the capital city of Niamey. Through Première Urgence, USAID/OFDA support will rehabilitate three health centers and provide necessary medical equipment, while staff will receive training in the detection and treatment of acute malnutrition. The program endeavors to increase health center capacity, seeking to reach nearly 23,000 children under five years of age with nutrition support.
